Mr. Orewiler updated the Board on the 2890 Alta West proceedings.

Mr. Gleisinger updated the Board on some work done by the Road Department. They have been helping Sandusky Township, due to their road foreman out with knee surgery, with a tree removal and some mowing.

Mr. Gleisinger updated the board on the MS4 program.

Mr. Gleisinger attended the Richland County Regional Planning Commission meeting last Wednesday and presented the Board with their Project Priority Ballot.

The Board approved switching the offices of the Inspection Bureau and the Township Trustees/Fiscal Officer. The Zoning Inspector will remain in his current office.

FO Kochheiser created an account for unclaimed funds consisting of outstanding paychecks and issued letters to the employees of these outstanding checks. An Amended Certificate was also requested and received from the County Auditor adding the Agency Fund 9001 to our 2018 budget to allow these checks to be reissued when/if claimed.
