Chief Carey wanted to discuss the ballistic vests with the Board now that we are in a new year. He would like to purchase 8 new vests that have more protection than our current vests have. FF Wilson showed the Board the vests that we currently have and informed them of the differences. Below are two quotes from Fire Department Service & Supply:

Vests with full protection: \$8,600

Vests without plates: \$6,730

Trustee Daugherty was not happy with how it was handled regarding contacting Richland Uniform about purchasing the vests. There was no followup, and she wasn't given all the information. There were grants that she could have helped the township with.

Motion #11-22: Trustee Rose made a motion to purchase 8-ballistic vests from Fire Department Service & Supply in the amount of \$8,600, seconded by Trustee Daugherty and upon a roll call vote all members voted "AYE."

Chief Carey informed the Board of some clerical changes to the Part-Time Wage and Benefits document.

Motion #12-22: Trustee Rose made a motion to approve the revised Part-Time Wage and Benefits package for 2022. Revisions include correction to Firefighter II medic pay and the advanced EMT Pay, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Chief Carey asked the Board for permission to throw away 3-old bunks that have no value. FO Kochheiser asked if they could be donated to any shelters or charities. The Board agreed that if they can't be donated then they can be thrown away.

Trustee Daugherty asked the Board if they had a chance to review the Chain of Command policy. Trustee Gleisinger doesn't think the policy needs to be changed. Trustee Rose wasn't happy when the current Chain of Command policy was put into place. She agrees with Don and believes in the day-to-day chain of command but feels that the fireman should be able to approach them. They would direct them to supervisors if it was something that should go through them first. She believes in the open-door policy. Trustee Gleisinger is afraid that it will get chaotic, and no chain of command will be followed.

Motion #13-22: Trustee Daugherty made a motion to rescind Motion #133-21 as he feels it ties the hands of the fire and road department employees and the trustees need to be open to anyone who wants to talk to them, seconded by Trustee Rose and upon a roll call vote all members voted as followed:

Mr. Don A. Daugherty **AYE** 

Trustee Daugherty discussed replacing the road department 6100 tractor acharm mower. There are some townships that are and reacharm mower. There are some townships that are very interested in buying the tractor and will possibly pay more than the trade-in value of \$2,800. The Road Foreman received a quote of \$97,234.27 from AgPro for the new tractor and \$68,345 from The Dexter Company for the reacharm mower with a grand total of \$165,579.27.

Motion #14-22: Trustee Daugherty made a motion to accept the bid from Ag Pro for the new John Deere 6110M tractor in the amount of \$97,234.27 to come out of the Permissive Sales fund. The total does not include the tradein value of the old tractor, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Motion #15-22: Trustee Gleisinger made a motion to purchase a reacharm mower from The Dexter Company totaling \$68,345 to come out of the Permissive Sales fund, seconded by Trustee Daugherty and upon a roll call vote all members voted "AYE."

Trustee Gleisinger updated the Board on the road department. He gave the Board that Road Equipment Replacement Schedule. They had to repair the front brakes on their equipment service vehicle for \$2,600. Had a burial and servicing equipment as well as snow plowing.

Trustee Gleisinger informed the Board of how much over-time the road department worked in 2021.

The Board signed the Investment Agreement.

FO Kochheiser informed the Board that the 2021 Annual Reports are done if anyone wants to review them.

Trustee Rose wanted to discuss the process of using the ARPA funds to purchase a new ambulance. We will need to get something from the prosecutor saying that we can use the funds.

Trustee Rose opened the meeting for discussion on the Wage and Benefits Package. Jon Brown presented the Board with a document including some ideas that the Board could consider and some concerns regarding the revised package. Below are some of the concerns:

- The process of the changes and how they did not know anything until it was done and decided on.
- Changes made to the sick time accrual has not been implemented.
- Calculation of hourly rate.
- The overtime threshold
- Definition of active pay status.
- Staffing model
- Administrative overhead
- Sandusky Township: lack of manpower

A comparison of surrounding fire departments contracts with ours was given to the Board including yearly hours, hourly rate, FLSA cycle, active pay status, salary, and contract cycle/raises.

Trustee Rose would like the fireman to suggest 3-4 options to improve the department and help with costs. She appreciated all the time they put into it and will definitely read it over.

Trustee Daugherty thanked the fireman and believes clarity will be huge moving forward. We need to take care of you and we need to take care of the citizens. We will get it straightened out.

Trustee Gleisinger informed them that he was good with his numbers. Overtime and minimum manning was also discussed.

#### **Public Comment:**

Craig Hunt asked if the new tractor will come with the heavy duty tires. Trustee Gleisinger informed him that it's all in the quote. He also asked about fireman's pension being increased and if it will affect the residents. As of now, it will not affect the residents.

Motion #16-22: Trustee Rose made a motion to go into Executive Session at 9:07 p.m. to a discuss disciplinary issue. Trustee Daugherty seconded the motion and upon a roll call all members voted "AYE".

Motion #17-22: Trustee Rose moved to return to regular session at 10:14p.m., Trustee Daugherty seconded and upon a roll call all members voted "AYE".
