The HSA policy was discussed. Suggestions were made for possible quarterly funding reductions based on hire date. Also discussed was funding the HSA accounts more than once a year.

Health insurance rates came back at 4.91% increase and discussion about Form Fire and the need to not have to do it and we also can shop it. Trustee Rose will send everyone the information since it just came in around 4:30 pm so she will have all the information at the next meeting as well as dental.

Chief Carey talked to Mickey and he submitted 22 AFG Grants and only 8 has been awarded. All went to the final stage. Springfield should get an award, so long as funding does not run out.

We applied for a First Responder Wellness Recruitment & Resiliency Grant. We applied for 10% retention bonuses. We received notice that they are still working on this. This would be for uniformed personnel only, and would not include the Road crew or Adm. Asst. This issue will be discussed for other employees if we do receive the grant for the fire dept.

A.C Spellman interviewed Nathan Kamps, FFII-EMT and recommended him for hiring as a part-time firefighter.

Motion #177-2022: Trustee Carns made a motion to hire Nathan Kamps as a part-time firefighter effective October 17, 2022 with one-year probation, seconded by Trustee Gleisinger and upon a roll call vote 2 members voted "AYE" and Trustee Daugherty abstained.

Chief Carey asked the Board about the repair in the parking lot at St#1. This will have to be re-visited next Spring. The Board stated they would get bids. The Board may possibly have the roof repaired at St #1 next year as well.

Trustee Gleisinger informed the Board that the All American Drive property was mowed by the property owner and the property on Lex-Springmill has started cleaning up. They are also finishing up the mowing and will start leaf pick-up on Nov 1st.

Public Comment:

Craig Hunt asked if we are going to continue with non-participation of a couple of the Trustees or if we are going to get back to normal. Trustee Carns stated that she doesn't feel it will be a permanent situation. We are navigating the situation however, not very well, she stated. A better understanding of the situation has begun, and they are working through it.

Motion #178-2022: Trustee Carns made a motion to go into Executive Session at 7:17pm to discuss matters required to be kept confidential by federal law or rules or state statutes, Trustee Gleisinger seconded the motion and upon a roll call all members voted "AYE".
