Chief Carey informed him that he had an ethics document detailing what he can and cannot do & at that time Trustee Daugherty left.

The fire department has 28 SCBA air packs that require certain rechargeable batteries. The fire department only has one charger which is currently at St#2. Chief would like to buy another charger for St#1 and 7 more batteries totaling \$4,254.25 from Fire Safety Services.

**Motion #167-2022:** Trustee Carns made a motion to purchase a battery charger and 7 battery packs from Fire Safety Services for a total of \$4,252.25 to come out of the 2901 fund, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Chief Carey informed the Board that Jon Brown asked if he could buy his backup gear for \$3,000 to use at Franklin Township. The Board approved to allow Chief Carey to discuss the sale with the Chief of Franklin Township. If the Franklin Township Chief agrees to our terms and is willing to pay for the gear up front then we will sell the gear.

Chief Carey submitted another public records request. He has not received a response to the 2 previous public records requests from all the trustees. If he does not get the requested material from Trustee Daugherty within 2 weeks, he will be filing a formal complaint with the Ohio Attorney General's office. Chief also stated that he has dealt with a hostile work environment and numerous civil rights violations since he came back from his heart transplant. Excerpts of a letter was read from his attorney that will be included with the minutes. Chief informed the Board that Trustee Daugherty is still his employee, as he has never resigned his part-time position with the Fire Department and created an "Unpaid Volunteer" position for himself that the township does not even offer. There have been multiple ethical violations committed by Trustee Daugherty. Chief told the Board that Trustee Daugherty is to uphold all ethics laws moving forward. He also asked that the Board censor all decisions made by Trustee Daugherty and if not, then he will no longer attend the meetings. The Board will look into the process of censorship and get back to Chief at the next meeting.

Trustee Gleisinger updated the Board on the road department. The Alta West driveway end has been repaired. The new tractor has been delivered but still waiting on the mower. Perry Township has not picked up the mower they bought yet. The road department is putting together a list of roads that need patched.

**Resolution #168-2022:** Trustee Gleisinger moved to adopt a resolution recognizing October 16-22, 2022 as Stormwater Awareness Week. Trustee Carns seconded the motion and upon a roll call vote all members voted "AYE."

Trustee Carns updated the Board on the health insurance. Medical Mutual has not come back with their proposed renewal rate. Nancy from Assured Partners is also shopping for dental insurance and looking into orthodontics coverage.


