Present: Assistant Chief Spellman, Brian Butcher, Craig Hunt, Justin Brant

Mr. Brian Butcher, a consultant for wage and benefits from Clemons, Nelson & Associates was invited to the meeting by Trustee Daugherty. He stated their company specializes in human resources, wage and benefit issues and human resources activities, such as Incident Reports and Worker's Compensation Claims. They work with many agencies within the public sector and he has prepared a retainer agreement for our consideration. Mr. Butcher's company also works with Mansfield Fire Department. Collective bargaining is something else their company specializes it. They only work for employers not employees. Mr. Butcher will send an electronic version of the information, pricing and the retainer to Anita who will send it on to everyone. Trustee Gleisinger suggested a look into the cost is important. Trustees Carns and Daugherty think a professional, unbiased option would be helpful. They will review cost and action plan before next meeting and decide then.

Trustee Gleisinger updated the Board on the Road Department. The JD Mower tractor was delivered to Perry Township and payment was received. The steering shaft had to be replaced on snow plow #1.

Trustee Carns stated the Medical Mutual Health insurance renewal came back with a 2.01% increase.

Motion #185-2022: Trustee Carns made a motion to renew the health insurance for 2023 with Medical Mutual with a 2.01% increase in premiums, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Superior Dental renewal came in with no increase in premiums and none of the plans we looked at included orthodontia. Trustee Carns recommends leaving the plan as is.

Motion #186-2022: Trustee Carns made a motion to renew the Superior Dental insurance for 2023, keeping the current plan with no changes in benefits or premium, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Regarding the HSA Funding Policy Update for 2023, Trustee Carns recommends keeping the amounts the same, but proposes to include pro rating the amount based on hire date. Chief Carey would like to see the amount contributed to the HSA's to be higher since the deductibles increased. The employees feel like their salaries have decreased since their deductibles have increased so much. Trustees do not see it that way. Discussion ensued about hiring Clemson, Nelson and Associates and whether they should hold off on any benefit decisions until they decide whether or not to contract with them for negotiations. Trustee Carns believes there needs to be a middle ground and the company might be able to help find a solution for everyone. The board decided to hold off on the HSA funding decision until a later date.
