

**Motion #69-2022:** Trustee Rose made a motion to accept the resignation of part-time firefighter Ryan Kirby effective April 14, 2022, seconded by Trustee Daugherty and upon a roll call vote all members voted "AYE."

Chief Carey updated the Board on the grant for the exhaust system.

Trustee Rose asked if everything was in place for when Capt. Mullins is on medical leave. Chief Carey informed her that both him and AC Spellman have met with him to get trained on scheduling and payroll. Capt. Mullins will be meeting with Gracie tomorrow to train on payroll.

Trustee Gleisinger updated the Board on the road department. They replaced a drive pipe on Wittmer and Gfrer Road and replaced a cross pipe on Flowers Road. They bought 125 ton of salt on the county salt program. Received a complaint on Sheirer Road regarding some logging.

Trustee Gleisinger presented the Board with a quote for a new mower for the road department of \$7,000 to buy outright or \$3,379.20 if one of the mowers get traded in. Trustee Daugherty would like to see the specs of the new mower before making any decision.

Trustee Rose would like the road department to bring a list of "wants" to the Board like the fire department does.

Trustee Rose presented the Board with a document that gives 6 executive session reasons that have to be used to go into executive session.

The Board signed the March Management reports.

**Resolution #70-2022:** Trustee Rose moved to adopt a resolution of the Board of Township Trustees of Springfield Township, Richland County, Ohio retaining Renwick, Welsh, and Burton LLC, Attorneys at Law, to provide additional legal services to this township at a rate of \$140 per hour, seconded by Trustee Daugherty and upon a roll call vote all members voted as followed:

**Motion #71-2022:** Trustee Daugherty made a motion to enter into agreement with Richland County Public for mosquito spraying to include 17 miles of township roads for a cost of \$937.55, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

The Fiscal Officer increased the tonnage for the 2023 Richland County Salt contract to 600 tons instead of the original 300 tons as stated at the last meeting. This increase came after discussing the amount with the Road Department.

FO Kochheiser updated the Board on the 2023 BWC Group Retrospective Rating renewal with Sedgwick. Our 2023 premium was decreased \$500 by Sedgwick over the price stated at the last meeting (re: Motion #63-2022).

**Public Comment:**

Craig Hunt asked why they were looking at the side discharge instead of rear discharge and how would it work to have the old lawnmower be given to the fire department. He thinks they should be able to get the discharge that they'd like to have. Trustee Gleisinger said it can either stay at the road department or the fire department and there would be no charge. He also gave his input on how the grass at St#1 could be mowed.

**Motion #72-2022:** Trustee Rose made a motion to go into Executive Session at 7:26 p.m. to discuss conferences with the Board's attorney to discuss matters which are the subject of pending or imminent court action. Trustee Gleisinger seconded the motion and upon a roll call all members voted "AYE".


