Chief updated the Board on our pending AFG/Safer Grant. 85% of AFG money has already been awarded and 50% of Safer grant money has already been awarded, however, additional funding has been allocated with +\$90 million for AFG Grants and +\$200 million for Safer Grants. We are still in the running for both. We will be notified by December 31, 2022, if our applications are

An old hose tester needs to be disposed of. It needs valves replaced but has monetary value. The Board gave Chief approval to sell it on GovDeals.

FF Jon Brown has taken a position with another township and has resigned his full-time status effective October 7, 2022. He has requested a part-time position.

**Motion #156-2022:** Trustee Carns made a motion to accept Jon Brown's resignation as a full-time firefighter but he shall remain on the department as a part-time firefighter effective October 7, 2022, seconded by Trustee Daugherty and upon a roll call vote all members voted "AYE."

A/C Spellman recommended Angelo Tino, FF/EMT and Allison Marstiller, FF/EMT as potential hires as part-time firefighters.

**Motion #157-2022**: Trustee Carns made a motion to hire Angelo Tino, FF/EMT and Allison Marstiller, FF/EMT as part-time firefighters, subject to a one-year probationary period effective September 19, 2022, seconded by Trustee Daugherty and upon a roll call vote all members voted "AYE."

A/C Spellman has some additional applicants he will be looking into as well.

Chief Carey discussed the tax levies and the information received from the county auditor regarding valuation of real estate.

Trustee Gleisinger read in the recent OTA magazine that the hours a parttime FF can work was increased to 1,976 hours instead of the previous 1,500 hours.

Trustee Gleisinger received a call from the contractor that asphalted the driveway @ 2260 Alta West, and he will be fixing the end of the drive soon. Also, the concrete work by Jim Herrick has been completed and the homeowner is happy with the repair. We received a high grass complaint for All American Drive and Scotty has sent a letter and we also received a nuisance complaint for 551 Lex-Springmill Road and a letter was also sent out. The new JD Tractor has been received by AgPro and is being finished up and should be ready for delivery to Dexter for the mower install.

Trustee Daugherty asked Trustee Gleisinger to clarify to email he sent regarding the 10% bid bond for contracts. Trustee Daugherty thinks any job over a certain amount of money should include a performance bond. Trustee Gleisinger disagrees and stated that It's not just the amount of the contract, but also the amount of time the contract is for.

FO Kochheiser informed the Board that due to the promotion of Kirstin Gray, she is looking to hire an assistant Fiscal Officer, pursuant to ORC Section 507.201 to assist with taking and preparing the minutes and other duties as she sees fit. She will be gathering resumes and filling this position in the very near future.

**Motion #158-2022**: Trustee Carns made a motion to approve the August Management reports, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Trustee Gleisinger discussed our current HSA policy and whether the amount should be prorated based on the hire date. The Board will look into the policy and update it for 2023.

FO Kochheiser asked about the Superior Dental renewal that was suspended from last meeting. Trustee Carns is still looking into this and will have it at the next meeting. Form Fire should be opened by October 1, 2022.

**Resolution #159-2022**: Trustee Carns made a Resolution to Reimburse Kirstin Gray for her Health Care Premiums due to her signed waiver of 2022 health insurance offered by the Township, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

FO Kochheiser updated the Board on the 2021/2022 Audit and the RFP and provided the Board with copies of all the information she has received from them. She has completed the initial questionnaire and will be emailing that back to the State Auditor.

FO Kochheiser thanked Trustees Daugherty & Gleisinger for their help last week going through old records. Most of the township records are ready for shredding and a Special Records Commission Meeting will be held to approve additional RC3's for township and fire department on October 3, 2022 @ 6:30pm.

A/C Spellman informed the Board of the increase in cost for Shred-it to do on-site pickup and shredding. New quote is \$1,530.40.

Resolution #160-2022: Trustee Carns made a Resolution Accepting the Amount and Rates as Determined by the Budget Commission & Authorizing the Necessary Tax Levies & Certifying them to the County Auditor for 2023, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

#### **Public Comment:**

Craig Hunt asked if the Chip & Seal was completed and whether Alta West was done.

FF Rich Metzger stated there have been 14 force-ins in the first 19 days of September. He expressed his discontent with the current staffing model at the fire department. He was forced in today and previously, missing family events and does not feel it is fair and wants to know who the judge is of what a "hardship" is. He feels this is all caused from the change in the Wage & Benefit Package previously made by the Board and thinks they should be compensated at time & 1/2 for any time worked over. He suggests possibly split shifts and additional staffing. A/C Spellman agrees we need additional staffing, and we are working to fix this problem and believes that "Our employees are our most valuable asset." Chief Carey explained the reasoning for the force-ins and further discussion ensued on this topic.

Trustee Daugherty left the meeting prior to Executive Session.

Motion #161-2022: Trustee Carns made a motion to go into Executive Session at 9:00pm to discuss the appointment, employment, dismissal, discipline, promotion, demotion or compensation of an employee or official, or the investigation of charges or complaints against an employee, official, licensee or student, unless the employee, official, licensee or student requests a public hearing. Trustee Gleisinger seconded the motion and upon a roll call all members voted "AYE".

Motion #162-2022: Trustee Carns moved to return to regular session at 9:25p.m., seconded by Trustee Gleisinger and upon a roll call all members voted "AYE".
