letter that they received stating the increase and reasoning for it. We assumed we were under contract and the price could not change.

Trustee Gleisinger stated the MARCS money from the State is still in the works and nothing is finalized yet. FF Metzger stated he found out it wouldn't be until the 2024/2025 budget year.

The Road crew has been ditching on Bowers and Springmill-North. Helped Sandusky township with organizing their signage.

Trustee Gleisinger got pricing on the driveway for Asphalt vs. Concrete for the parking lot at Station #1 as well as quotes for a new roof. The driveway estimate is \$55,350.00 for Asphalt and this obviously would need to be bid. The roof quote was \$45,625.00 also for St #1. This also will need to be bid. Bid specs need to be done for both items.

The letter regarding the increase of the chassis of the ambulance from Pfund was found and presented by Lt. Shelton and discussed amongst the Board.

Motion #29-2023: Trustee Carns made a motion to increase funds allocated for the Lifeline Ambulance purchase from \$288,122.00 to \$298,156.00 based on the letter received from the vendor, seconded by Trustee Daugherty, and upon a roll call vote all members voted "AYE."

FO Kochheiser presented the Board with the 2023 Permanent Appropriations.

Motion #30-2023: Trustee Carns made a motion to accept the 2023 Permanent Appropriations as prepared by the Fiscal Officer to make it possible to pay the bills for 2023, seconded by Trustee Daugherty, and upon a roll call vote all members voted "AYE."

FO Kochheiser also presented the Board with the February Management Reports and same was approved and signed.

FO Kochheiser then informed the Board that she heard from APA Amanda Middis late today regarding the opinion she requested about the payment of the Net2 Services invoice for the installation of the camera in the meeting room that was not approved by the Board. APA Middis advised that we would get a finding from the Auditor for misappropriation of funds if we paid the invoice as Trustee Daugherty acted without Board approval.

Trustee Carns agreed that we need to pay the bill. Trustee Gleisinger agreed also as long as the camera comes down.

Motion #31-2023: Trustee Carns made a motion to pay \$409.99 for the work to install the camera and for the camera to be removed. Motion died for a lack of a second.

FO Kochheiser advised they first need a motion to install the camera. Then a motion to pay the bill and thirdly a motion to remove the camera. Protocol has to be followed, starting from the beginning. No one would make these motions and this issue was tabled.

Public Comment:

Craig Hunt wanted to know if there was a chance of just turning this camera off and leaving the other ones on. He suggests just unhooking it.

Rich Metzger is hoping a decision is made soon regarding wage & benefits. Report received from Clemans today and Trustee Carns forwarded it to the others just prior to the meeting.

Motion #32-2023: Trustee Carns made a motion to go into Executive Session at 7:37pm to discuss the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of an employee or official, or the investigation of charges or complaints against an employee, official, licensee or student, unless the employee, official, licensee or student requests a public hearing, Trustee Gleisinger seconded the motion and upon a roll call all members voted "AYE."

Motion #33-2023: Trustee Carns moved to return to regular session at 8:05pm, seconded by Trustee Gleisinger, motion carried.

Trustee Carns stated that based on the study done by Clemans and Nelson we are behind on pay and they suggest a three-year raise as follows for all full-time employees: 2023-10%; 2024-3% & 2025-2% and \$1 hr. for part-time for 2023 only, revaluated after this year.

Motion #34-2023: Trustee Carns made a motion based on the study and recommendation done by Clemans and Nelson to raise the salary on a three-year tier as follows: for all full-time employees: 2023-10%; 2024-3% & 2025-2% and \$1 hr. for part-time. The Board realized there are other items regarding benefits that need addressed and they want to sit down with the group. They just didn't want to wait any longer to give raises for the employees. The full-time raises are to be retroactive to 12/17/2022, the first pay of 2023, and will be based on the bi-weekly rate only for the first five pay periods of 2023. The part-time raises will be effective on March 11, 2023, seconded by Trustee Gleisinger, and upon a roll call vote all members voted "AYE." Motion carried.

Cpt. Mullins stated by giving the increase to only the bi-weekly salary for the retroactive pay will result in the employees not receiving their true raise by the end of the year. This was further discussed and FO Kochheiser explained to him that they would receive the correct amount. The 10% raise will not be applied to any extra hours worked or overtime, only the bi-weekly salary thus making their salary whole by the end of 2023.

Lt. Shelton stated from a supervisor's standpoint the FLSA is the biggest headache for him. Nobody wants to cover shifts and work for straight time. People are being mandated to work more than ever right now and not happy about it. We need to hire more medics as we are short on them as well.

FF Rich Metzger also stated his frustrations with the FLSA change and would like to see things changed back to how it was. There was much discussion on benefits between the Board and the firefighters present. The Board will be getting back to them to sit down and further discuss this matter.

Motion #35-2023: There being no further business to come before the Board, Trustee Carns made a motion to adjourn, seconded by Trustee Daugherty, motion carried.

The meeting adjourned at 8:42 pm.
