I/C Spellman revisited the Fire Cost Recovery. He contacted several departments in the area. Mifflin & Madison both use it, as well as Mt. Gilead and Polk. They are all pleased with it. Mifflin recovers around \$40,000 annually

with them. They are flexible with the billing options and only bill what we send them. Decisions will need to be made as to how we would want to proceed. The prosecutor has already reviewed the contract. I/C Spellman will iron out some details, and it will be returned to the Board next time for approval.

The need for a new ladder truck was again discussed. Option 1 order a new truck that will take 2-3 years to build and will cost from Sutphen \$1.34 million. Price increase is coming in June. Option 2 would be to get a used truck while the new one is being built. Option 3 is to just buy a used ladder truck. Or the final option is to keep what we have and continue to put money into it. A list of used trucks was given to the Board. I/C Spellman also stated that Brinley Mountain will sell our existing ladder truck and charges commission ranging from 5-10% depending on the price it sells for. (\$300K or more = 5%, \$150K-\$300K = 7% and less than \$150K = 10%). Trustee Carns & Daugherty stated that a new truck is not an option. The Board wants them to attempt to sell our ladder at \$350K and go from there.

Motion #69-2023: Trustee Daugherty made a motion to list our 2005 KME Ladder truck with Brinley Mountain for \$350K, seconded by Trustee Glesinger and upon a roll call all members voted "AYE."

I/C Spellman presented two sick leave donation forms for the Boards approval, and they both were signed.

Motion #70-2023: Trustee Carns made a motion to approve the sick leave donation of 48 hrs. from Josh Bradley and 96 hours from Rich Metzger to go to an employee within the Fire Department with a medical condition, seconded by Trustee Gleisinger, and upon a roll call vote all members voted "AYE."

I/C Spellman presented the updated training reimbursement request forms from three (3) employees within the fire department for tuition reimbursement for the Board's approval.

Motion #71-2023: Trustee Carns made a motion to enter into an Agreement for Training Reimbursement between Colton Shelton and the township for \$7,200 tuition and \$350.00 in expenses with the agreement of reimbursement as stated in the agreement should he leave employment, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Motion #72-2023: Trustee Daugherty made a motion to enter into an Agreement for Training Reimbursement between Nathan Volz in and the township for \$7,400 tuition and \$350.00 in expenses with the agreement of reimbursement as stated in the agreement should he leave employment, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

The third agreement will be returned at the next meeting as the employee has not signed it yet.

I/C Spellman recommends Jeffrey Krumlaw FFII/EMT for part-time employment.

Motion #73-2023: Trustee Carns made a motion to hire Jeffrey Krumlaw as FFII/EMT on a part-time basis effective today, with a one-year probationary period, seconded by Trustee Gleisinger and upon a roll call vote, all members voted "AYE."

I/C Spellman also asked if the Board has reviewed the job description for the Part-time Trainees and they all agree they have not had a chance to review it, but Trustee Gleisinger states he will do so by the next meeting.

The road dept's new roller came in, and they used it to patch the St#1 holes. The cemetery issue has been resolved. Mowed cemeteries and did all the seeding and assisted the fire dept with an accident last week. Possible bad turbo on the road truck #3 and it needs/or may have already been repaired.

FO Kochheiser presented the April Management Reports to the Board, and they approved and signed the same.

Public Comment:

Craig Hunt – asked on the Cost Recovery if we ever talked to Pfitzmeyer (our insurance company) to see if it is a good idea to get another side/opinion and do we really need to money? Is it really going to help our township? He also asked about the roller to make sure it came in complete, and it did. Trustee Daugherty stated that he did discuss this with Rinehart Insurance and there would not be an increase in premiums.

FF Wilson asked about Clemans and Nelson and whether they have the ability to join us in talks with the City of Ontario to help fund the fire dept., as 80% of runs are within the City and the tax abatements they offer hurt our township. Trustee Carns stated this is something we can look into once the wage and benefits are finalized.

Motion #74-2023: Trustee Carns made a motion to go into Executive Session at 7:59pm to discuss the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of an employee or official, or the investigation of charges or complaints against an employee, official, licensee or student, unless the employee, official, licensee or student requests a public hearing, Trustee Daugherty seconded the motion and upon a roll call all members voted "AYE."

Motion #75-2023: Trustee Carns moved to return to regular session at 9:18pm, seconded by Trustee Daugherty, motion carried.

Motion #76-2023: Trustee Carns made a motion to consult with the State Auditor on payment of COBRA premiums payments, seconded by Trustee Daugherty and upon a roll call vote all members voted "AYE".

Motion #77-2023: There being no further business to come before the Board, Trustee Gleisinger made a motion to adjourn, seconded by Trustee Carns, motion carried.

The meeting adjourned at 9:20pm.
