\$2,558.92. Trustee Orewiler and Daugherty asked if a second quote was obtained. Chairman Gleisinger will obtain a second quote and bring back.

Chairman Gleisinger would like permission to talk to and send contract to Attorney Burton to get ahead of the Tower situation. The Board agreed.

Trustee Gleisinger believes the Fire Chief position should be decided. Chief Carey has been gone for a year now and IC Spellman has already gone through the interview process for Interim Chief along with other candidates. Trustee Daugherty would like the position to be posted publicly as an open position to interview other candidates before deciding and Trustee Gleisinger would like the position to stay internally.

Motion #4-2024: Trustee Gleisinger made a motion to appoint Adam Spellman as Fire Chief effective January 8th, 2024, seconded by Trustee Orewiler and upon a roll call vote:

Trustee Daugherty: Nay

Salary and job description will be discussed at a future meeting.

Chief Spellman discussed selling the old Med 22 ambulance. The ambulance is stripped, and Chief Spellman inquired how Trustee's would like to proceed with selling it. Trustee Daugherty would like to put it in Fire Truck Trader magazine.

Marengo needs Fire Vehicles because three of their vehicles went down. Marengo has a Board meeting on Thursday and Chief Spellman would like to sell Engine number 23 to them. A new Engine is needed before selling Engine number 23 and the Board would like to wait until they find exactly what they want before purchasing new one. Financing for the new truck needs to be discussed.

Cradle Points are having problems staying connected and their life expectancy is up in November. Chief Spellman would like to purchase 10 new 5g Cradle Points for \$20,000.00. It is something they will need for the new CAD Systems to be able to stay connected. The Board will decide after they have gone to the Trade Show and researched other vendors.

Trustee Daugherty rescinded Motion #204-2023 Wage and Benefit package.

Motion #5-2024: Trustee Daugherty made a motion to accept Version number 6 for the Wage and Benefits package for full time employees of Springfield Township Fire Department, effective first pay period of 2024, seconded by Trustee Gleisinger, and upon a roll call vote all members voted "AYE."

Trustee Orewiler would like to call the South Carolina Fire Department to see exactly how much they paid for the Truck Springfield Township is interested in. He would also like to find out how much the broker is paying the South Carolina Fire Department for truck and exactly how much a new one is to see if the Department is getting a good deal. Trustee Gleisinger offered to go to the Trade Show with Chief Spellman to find out what new trucks are going for.

Trustee Orewiler asked Chief Spellman if a Full time Fire Inspector were to be hired would the Inspections pay for the full time Inspector. Chief Spellman needs more information to answer the question effectively. It's hard to say at this point because the bills are not paid immediately. Chief Spellman believes there is a need for a full-time Inspector due to over 600 locations that need inspected. This would ensure all locations could be inspected properly for safety issues. The position would also provide educational services to several organizations. The Board would like Chief Spellman to obtain a report over a five-year period of how much income inspections bring in and the pay and job description for a full time Inspector. Once information is obtained the Board will revisit.
