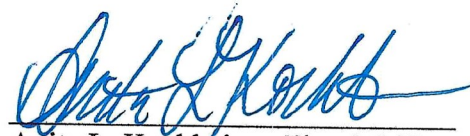

Marc Pfizenmayer reviewed the Ohio Plan Package Proposal with the Board. With some deletions and additions of equipment, the new premium is estimated to be \$31,928.00 after a credit of \$3,956.00, an increase of \$2,073.00. The premium is derived from Risk Management and Loss Ratio (Claims), as well as an increase in building materials and labor.

Chief Spellman presented the Board with the monthly report for September. There were 12 calls where mutual aid was given and 4 calls where mutual aid was received. September 13th there was a house explosion on Hook Road with multiple injuries and one fatality.

Chief Spellman received a resignation letter from Collin McBride for his Full-Time FF position, however FF McBride would like to remain as a Part-Time FF.

Motion #183-2024: Trustee Gleisinger made a motion to accept the Full-Time resignation of Collin McBride, effective October 23, 2024, and will accept Collin McBride staying with the Springfield Township Fire Department as a Part-Time FF, seconded by Trustee Orewiler, motion carried.

Chief Spellman recommended Kross Phelps to the Full-Time FF position that will be vacated by Collin McBride. FF Phelps is already trained and is a paramedic with experience working for Madison Township.

Motion #184-2024: Trustee Gleisinger made a motion to accept Kross Phelps to the Full-Time FF position vacated by FF McBride, effective November 9th, 2024, with a one-year probationary period, seconded by Trustee Orewiler, motion carried.

Chief Spellman requested Board approval to pay for Joseph Greifensteine to attend fire training which will be reimbursed through State Marshall Fire Grant. Board Approved.

The pick-up truck is ready to be picked up from the dealership and Trustee Orewiler asked Chief Spellman if he could possibly wait until after November 8th to take possession of the truck so the Township could receive a full year of insurance for free. Chief Spellman will call the dealership and see if they could hold the truck for them until then.

Trustee Gleisinger updated the Board on the Road Dept. Wiles Estate had a new drive installed where the Road Department completed the end. They maintained cemeteries and were a part of the funeral procession for the county worker who was fatally hit by a car while performing his work duties.

Trustee Gleisinger sent an article about the upcoming levies to the other Trustees from Richland Source and he would like them to approve the language before it is published.

Trustee Orewiler asked the Board if they needed his help on mowing since there is now a full crew at the Road Department. If he is willing to help Trustee Gleisinger advised Trustee Orewiler to call Charlie and come up with a schedule of what still needs to be done.

Trustee Orewiler wanted to inform the Board that there was oil found on Burnison Road through a Geophysical Seismic Test and the company will probably be requesting from the Township the ability to bring their equipment onto the edge of the roads to check for oil.

The generator was purchased four years ago, and Trustee Gleisinger was concerned the generator's diesel fuel may need to be checked. Trustee Gleisinger advised Trustee Orewiler to contact Cole Distributing to put an additive into the fuel to keep it operational.

FO Assistant Hike requested signatures from the Board for the September Management Reports that were emailed to each member. They were approved and signed by the Board.

FO Assistant Hike requested a resolution to realign the permanent appropriations to return \$5.70, the unused portion of the Ohio Ambulance Impacted Industry Grant, to the State of Ohio Treasurer.

Resolution #185-2024: Trustee Gleisinger made a resolution to approve the realignment of fund number 2275, to transfer \$5.70 from line-item number 2275-220-213-000 and to place the funds into line- item number 2275-220-190-000 to return the unused portion of \$5.70 from the Impacted Industry Grant to
