Chief Spellman has Fire Gear out in the barn and would like to find an outfit to take the gear to have more room for other items that need stored. Board approved.

There is equipment available, called a radio switcher, that costs \$2,300.00 and Chief Spellman would like to put one in the Chief's car to see how it works and then in the future get one for the fire engine. This device would provide a direct channel with seamless coverage and clarity. The Board would like to table this until a future meeting.

Chief Spellman would like to purchase 12 buckets of F-500 firefighting foam. The department is getting low and three other departments are willing to go in on the purchase, saving freight costs. The foam would come from Advanced Eco System. The total cost will be \$2,217.00 for the 12 buckets. The Board approved.

Chief Spellman would like to hire Justin Brant who interviewed for the Fire Inspector position. The Board would like to discuss the matter in Executive session before moving forward.

Trustee Gleisinger updated the Board on the productivity of the Road Department. The department has been helping Sandusky Township with tearing down their old salt shed so they can replace it with a new one and helping to put driveway in on Deerfield Road. The department is also chipping and sealing South of Home Road.

There will be a Township/County meeting that will discuss the finalization of the new Septic Tank Systems. These systems will need to be inspected every five years.

There will be a Health Department/Township meeting that will discuss the 911 plan.

Fiscal Officer Kochheiser discussed approval of re-enrollment into the Sedgwick-Group Retro Rating Program for 2025.

Motion #62-2024: Trustee Gleisinger made a motion to re-enroll into the Sedgwick-Group Retro Rating Program for 2025 at a cost of \$4,855.00 to be paid next meeting, seconded by Trustee Daugherty, motion carried.

FO Kochheiser reminded the Board of the Records Commission Meeting.

Public Comment:

Matt Carey quoted an excerpt from the March 7, 2023, meeting. "Trustee Daugherty asked about the process of seeking legal advice. The Prosecutor's Office is a free legal service, and he can go to them for any questions. If a 2nd legal opinion is needed (not free) then all trustees will need to agree before moving forward." Mr. Carey then informed the Board he had submitted a new public records request for the records he had previously requested but had not received yet.

Motion #63-2024: Trustee Gleisinger made a motion to go into Executive Session for the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of an employee or official, or the investigation of charges or complaints against an employee, official, licensee, or student, unless the employee, official, licensee, or student requests a public hearing at 7:06pm, seconded by Trustee Daugherty, motion carried.

Motion #64-2024: Trustee Gleisinger made a motion to return to regular session at 7:35pm, seconded by Trustee Daugherty, motion carried.

Motion #65-2024: There being no further business to come before the Board, Trustee Gleisinger made a motion to adjourn, seconded by Trustee Daugherty, motion carried.
