Chief Spellman presented the Board with the Fire Department report. The Fire Department performed 170 runs for the month including a couple of fires and accidents where extrications had to be performed.

Chief Spellman received resignation letters from Dennis Gast who is taking a full-time position at Madison Township Fire Department and Jeffrey Young who is going into the Military.

Motion #98-2024: Trustee Daugherty made a motion to accept the full-time resignation of Dennis Gast, effective June 22, 2024, and to approve him serving part-time effective June 23, 2024 at the current hourly part-time rate, seconded by Trustee Gleisinger, motion carried.

Motion #-99-2024: Trustee Orewiler made a motion to accept the resignation/5-year Military leave of absence of Jeffrey Young Jr., effective July 1, 2024, and advised him to keep in contact in the instance he would like to come back to the Fire Department once his service is completed, seconded by Trustee Daugherty, motion carried.

Chief Spellman would like to hire for part-time employment 1) Collin Hart who has 3-4 years' experience and has Fire Card & 2) Adam Crider who is EMT certified and has his Fire Card 9. He also recommends Gage Potter as full-time to replace Dennis Gast. He has been working part-time for the Springfield Township Fire Department and is doing a good job with no complaints from fellow Firefighters.

Motion #100-2024: Trustee Daugherty made a motion to hire Collin Hart as P/T FFI/Advanced EMT, effective June 29<sup>th</sup>, 2024, provided he passes the agility test, with a one-year probationary period, seconded by Trustee Gleisinger, motion carried.

Motion #101-2024: Trustee Orewiler made a motion to hire Adam Crider as P/T FFII/EMT, effective June 29, 2024, provided he passes the agility test, with a one-year probationary period, seconded by Trustee Daugherty, motion carried.

**Motion #102-2024:** Trustee Gleisinger made a motion to hire Gage Potter as F/T FF/EMT to replace the position Dennis Gast vacated, effective June 29, 2024, with a one-year probationary period, seconded by Trustee Orewiler, motion carried.

Chief Spellman has the Board sign the updated Ambulance Quote with the total cost of \$342,262.00. The down payment of \$68,452.40 is ready to mail. The estimated delivery time will be 3 years after the order has been placed.

Tyler Daniels, whose father worked for the Springfield Township Fire Department for many years requested the Board to sponsor him for his fire training. He lives and works in Ontario. Board approved.

Chief Spellman asked the Board for approval of an influx of hours for the 4<sup>th</sup> of July festival. He would like to have 5 on staff for the festival. Board approved.

Trustee Gleisinger has put specs out for bid in the Tribune and on the web for Road Paving work for 2024. FO Kochheiser mentioned that a motion has not been made for that yet and needs to be made in addition to receiving Board approval last meeting.

Trustee Gleisinger updated the Board on the Madison Co-operative Paving Agreement. It is not quite finished and will be brought to the Board once it is ready to sign.

Trustee Gleisinger read a proclamation to make June 30<sup>th</sup> William Scott day in Springfield Township. William Scott resigned as Zoning Inspector after working for Springfield Township for 16 years providing consistency and leadership to the Township.

Trustee Gleisinger proposed two resolutions to proceed with the submission to the electors of taxes in excess of the Ten-Mil limitation.

**Resolution #104-2024:** Trustee Gleisinger moved for the adoption of the following Resolution:

Whereas, on the 28th day of May, 2024, this Board adopted a resolution determining to submit to the electors of Springfield Township, Richland County, Ohio, described below, a copy of which resolution was certified to the County Auditor of Richland County, and whereas the property tax revenue that will be produced by the stated millage, assuming the taxable value of the subdivision remains constant throughout the life of the levy, is calculated to be \$429,000.00. (2) The total taxable value of the subdivision used in calculating the estimated property tax revenue is \$414,886,620.00. (3) The millage for the requested levy is 1.5 mills per \$1 of taxable value, which amounts to \$53.00 for each \$100,000 of the county auditor's appraised value. Now therefore, be it resolved by the Board of Springfield Township Trustees of Richland County, Ohio that this Board desires and determines to proceed with the submission to the electors of the question of levying a tax in excess of the ten-mill limitation for the benefit of Springfield Township, Richland County, Ohio, for the purpose of providing and maintaining fire apparatus and appliances, buildings, or sites therefor, or sources of water supply and materials therefor, or the establishment and maintenance of lines of fire alarm telegraph, or the payment of permanent, parttime, or volunteer firefighters or fire-fighting companies to operate the same, including the payment of firemen employer's contribution required under Section 742.34 of the Revised Code, or to purchase ambulance equipment, or to provide ambulance or emergency medical services operated by a fire department or firefighting company pursuant to R.C. 5705.19(I), at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to \$0.53 for each one hundred dollars of valuation for five (5) years, and which levy is a renewal of an existing levy. The question of approving the levy shall be submitted to the electors of Springfield Township at the election to be held on the 5th day of November, 2024 and that said levy be placed on the tax lists of the current tax year, commencing in 2024, first due in the calendar year 2025 in compliance with the provisions of ORC 5705.34, if a majority of the electors voting therein vote in favor thereof. The Fiscal Officer of this Board is directed to certify a copy of this resolution to the Board of Elections of Richland County, Ohio, not less than ninety days before the election, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law. It is found and determined that all formal actions of this Board concerning and relating to the adoption of the resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in those formal actions were in meetings open to the public, in accordance with the law. Trustee Daugherty seconded the resolution and the roll being called upon its adoption, the vote resulted as follows: Paul Gleisinger "Aye", Don Daugherty "Aye", and Brad Orewiler "Aye," motion carried.
