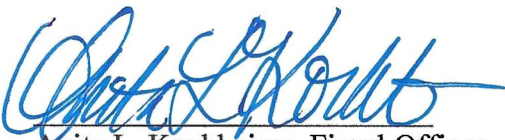

Trustee Gleisinger presented the Board with an update on the Road Department. They had 3 burials, patching roads, a couple of driveway approaches, and helping Sandusky Township with moving items out of old building into their new building. The first week of August the Road Department will start mowing roads and cemeteries.

Trustee Gleisinger would like the township website updated to reflect the new Zoning Inspector, Steve Arnett, and would like the county website linked with township website so that residents can report issues and know where to look to get issues resolved.

Trustee Orewiler presented the Board with an updated contract from Ambrose Asphalt, Inc. The new contract reflects the mill grindings to be transported to the township.

Trustee Orewiler received complaints from residents on the maintaining of weeds on the roadways. The township was late mowing the first time and there has not been a second time. Trustee Orewiler offered to help mow. Trustee Gleisinger did not want to add mowings since the Road Department is down one
