Motion #142-2024: Trustee Daugherty made a motion to hire FF Justin Brant as full time Fire Inspector, effective August 24, 2024, with a one-year probationary period, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

Chief Spellman asked for Board approval to sponsor Mason Ferguson for fire training at a cost of \$1,550.00. Board approved.

The Fire Dept. pickup truck, SU#22 is 14 years old and is rusting out and Snowpyo Jarrod Strouth is looking for replacements for the pickup truck. He found one with a snowplow for \$52,000.00. Trustee Daugherty requested a price from Dodge before moving forward.

Trustee Gleisinger updated the Board on the activities of the Road Department. Charlie has been working on driveways and asphalting roads. Mowing will start as of August 6, 2024.

Trustee Orewiler asked if the township is responsible for mowing the bridge embankments on Earick Rd. Since the road is an overpass on St. Rt. 30, the state would be responsible for maintenance.

Regarding the paving at St#1, Trustee Daugherty expressed his frustration with Ambrose Asphalt as they applied additional paving which was more than they bid. Trustee Orewiler informed the Board that we will only be charged for what was bid and he oversaw the entire process and he feels that Ambrose Asphalt did a great job.

FO Kochheiser discussed developing a budget for Mr. Strouth to finish the landscaping at Station #1. He wanted to put down thick plastic for weed control and add stone. Trustee Gleisinger advised Mr. Strouth to call Arnold's and get some ideas for landscaping and prices, then next spring new landscaping can be implemented. In the meantime, Mr. Strouth will use a weedkiller to control the weeds.

FO Kochheiser presented the Board with the July Management Reports for approval. Board approved and signed.

FO Kochheiser discussed the new Ambulance Retention Grant Award with the Board. The new grant award is for members that were present during Covid, full & part time and routinely picked up hours. Trustee Gleisinger wanted the Fire Dept. Admin Asst., road department supervisor Charlie, and the Fire Dept, mechanic to receive the same amount of a retention bonus as the other employees even if it had to come out of a different fund.

Motion #143-2024: Trustee Gleisinger made a motion to accept \$24,361.00 from the Ohio Office of Budget Management/Ohio Ambulance Impacted Industry Grant for purpose of giving Retention bonuses in the amounts to be determined, which will include reducing the employee awards to cover employer-paid fringe pensions & Medicare which was received & deposited on July 26, 2024, seconded by Trustee Orewiler, and upon a roll call vote all members voted "Aye".

Motion #144-2024: Trustee Gleisinger made a motion to approve the 2024 Amended Certificate, adding the Ohio Ambulance Impacted Industry Grant (Fund 2275) in the amount of \$24,361.00, dated July 26, 2024, seconded by Trustee Orewiler, and upon a roll call vote all members voted "Aye".

Motion #145-2024: Trustee Gleisinger made a motion to approve the 2024 Amended Appropriations to add the new Ohio Ambulance Impacted
